Course Description

The course will focus on the basic research methods (quantitative, qualitative and mixed methods) and the development of the skills that will be required to write effective research papers throughout their MBA program. Topics include understanding the ethical considerations of doing research, developing and refining research topics, crafting a problem statement, and formulating research questions and hypotheses. Students will evaluate and critique the quality of published literature by employing critical thinking skills, writing summaries for individual entries in a literature review, and/or writing comprehensive summaries of articles for a literature review. Students will also practice writing the various sections of a research paper such as the abstract, introduction and theoretical background, problem statements, etc.

Plagiarism and Academic Misconduct:

Plagiarism: includes, but is not limited to:

- Submission of another person's work as original;
- Inadequate attribution given to an author or creator whose work is incorporated in the student's work; and
- Paraphrase or use of material verbatim from a source without sufficient acknowledgement.

Falsifying Materials: includes, but is not limited to:

- Fraudulently manipulating laboratory processes, electronic data, or research data in order to achieve desired results;
- Submitting work prepared by someone else (e.g., commercially prepared essays) as one's own;
- Citing a source from which material was not obtained; and
- Submitting false records, information or data, in writing or orally.

Cheating: includes, but is not limited to:

- Submitting the same work for different courses without prior permission from the faculty member;
